- h. Evidence of Payment of Tax and Development levy for the last 3 years (2016, 2017 &2018) for two Directors.
- i. Evidence of current registration with Lagos State Public Procurement Agency in appropriate Class.
- j. A sworn Affidavit that all documents submitted is genuine and verifiable.
- k. Any additional information that may enhance your bid.
