1.0 INTRODUCTION

The West African Center for Public Health and Development (WACPHD), an affiliate of the University of Manitoba, is a non-governmental organization dedicated to improving health equity through research, program delivery, technical assistance, and education. We are soliciting quotations for the rental of vehicles to support the Family Planning/MNCH- Supply Side Baseline Assessment (FP/MNCH-SSBA) project funded by the Bill & Melinda Gates Foundation (BMGF). The purpose of this RFQ is to identify and engage a qualified vendor that can provide reliable transportation for project activities in Lagos.

2.0 SCOPE OF WORK

The selected vendor will be responsible for the following:

- Provide vehicle rental services daily for the required number of days in Lagos State.
- Provide dedicated drivers for each vehicle.
- Ensure all rented vehicles have comprehensive insurance coverage and a GPS-tracking system.
- Cover fuel and maintenance costs in the rental agreement.
- Offer 24/7 customer support for any issues that may arise during the rental period.
- Ensure prompt replacement of vehicles in case of breakdown within 24 hours.
- Comply with all local traffic regulations and safety standards.
- Regularly maintain and clean the vehicles.
- Require drivers to complete daily vehicle logbooks, including destination, date, driver's name, car plate number, start and end time per trip, and mileage.

Vehicle Type: Minivans (e.g., Toyota Sienna, Honda Odyssey) with a 6-passenger capacity

Quantity: 12 vehicles

Contract Duration: 105 days

Contract Award: One or more suppliers may be awarded the contract



3.0 GENERAL ELIGIBILITY CRITERIA

All procurement activities of this Organization shall be fully governed by the approved Procurement Guidelines in the Public Procurement Act (PPA 2007). The following mandatory requirements must be met by all prospective bidders:

- Evidence of Certificate of Incorporation with the Corporate Affairs Commission (CAC) with the inclusion of Articles of Association (forms CAC2 and CAC7).
- Evidence of the Company's Income Tax Clearance Certificate for the last three (3) years valid till 31st December 2023.
- Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years, including Letters of Awards and Job Completion Certificates.
- At least 5 years of working experience in car rental services in Nigeria.
- Vendors must possess valid insurance for the vehicles offered for rental.
- Evidence of physical registered office (e.g., utility bill or tenancy agreement with the name of the firm).
- All documents for submission must be uploaded online with a Covering/Forwarding letter under the Company/Firm's Letter Head Paper bearing among others the Registration Number (CAC), Contact Address, Telephone Number (Preferably GSM No.), and Email Address. The Letterhead Paper must bear the Names and Nationalities of the CEO/Directors of the Company at the bottom of the page duly signed by the authorized officer of the firm.
- Vendors must comply with all local regulations regarding vehicle operation and safety.
- Our organization reserves the right to reject any or all bids.
- Should your organization be successful in the selection process, our organization shall withhold and remit the appropriate tax rate under which your professional service falls as required by law.



4.0 INSTRUCTIONS TO SUPPLIERS



SUBMISSION OF QUOTATIONS

Interested suppliers should adhere to the following instructions when submitting their quotations:

ESSENTIAL INFORMATION

Vehicle Specifications and Features:

- Vehicle type (e.g., sedan, SUV, minivan)
- Brand name and model
- Seating capacity
- All vehicles must be in excellent working condition, regularly maintained, and insured.
- Additional features or specifications

Duration of Rental

• Total Duration: 105 days

Requirement of the contractor:

- Minimum experience of five years in the provision of vehicle hire service
- Fuel should be provided by the contractor
- Maintenance to be carried out by the contractor
- The vehicle should be compliant with applicable insurance, safety, or other motor vehicle requirements
- Registered for operation during the contract period with registration documentation in the vehicle and registration/number plates affixed to the vehicles as required by law.

Condition for the vehicle:

- The vehicle should be registered with up-to-date particulars, roadworthy, in good running condition, and not more than 12 years old
- The vehicle should be equipped with necessary safety items: seat-belt restraints in the front and rear of the vehicle, a spare tire, a mechanical jack, and basic hand tools
- The vehicle should have comprehensive insurance
- The vehicle should have good tires



Requirements for the driver:

- The driver should have a minimum of 5 years of work experience, a safe and clean driving record, knowledge of driving rules and regulations, and skills in minor vehicle repair.
- The driver should be able to communicate and write in English and speak the local language of the area.
- The driver should have a valid driver's license and be familiar with local routes and destinations.

Submission Requirements

Interested vendors must submit the following documents:

Company Profile:

- Company name, address, and contact details.
- An overview of the company's experience in providing vehicle rental services, particularly for similar public health projects.

Detailed Quotation:

- A comprehensive cost breakdown for the rental of each vehicle, including all associated costs (fuel, maintenance, driver, insurance).
- The total cost for the entire duration of 105 days.

Vehicle Information:

- A detailed description of the vehicles available for rental (make, model, year).
- Information regarding maintenance records and insurance coverage.
- Qualifications and experience of the drivers to be provided.

References:

 At least two references from clients who have utilized your services within the last 12 months, preferably in similar projects.

Compliance and Insurance Documents:

When engaged you will be asked to submit the following:

- Proof of insurance coverage for vehicles.
- Any necessary permits or licenses for operation within Lagos.



Bidders must consider the following essential information when submitting their quotation

Evaluation and Comparison of Quotations:

- Compliance with the specifications and requirements outlined in this RFQ
- Price competitiveness
- Conformity to technical specifications
- Verification of any arithmetical errors. For instance, discrepancies between quoted figures and words shall defer to the amount stated in words. Additionally, any discrepancies between unit prices and their calculated totals shall defer to the unit price; the total price shall be adjusted accordingly.

Notification of the award shall constitute the formation of the contract.
