1. Background

Royal Heritage Health Foundation (RHHF) is a Nigerian non-governmental, non-profit organization and an Implementing Partner (IP) of the United Nations Population Fund (UNFPA). RHHF works to ensure equitable access to quality health, education, and social support for vulnerable populations.

To enhance the delivery of Sexual and Reproductive Health (SRH) and Gender-Based Violence (GBV) services across Benue, Borno, Adamawa, and Yobe States in Nigeria, RHHF invites qualified and reputable vendors to submit bids for the **provision of truck and bus for hire to convey dignity kits** as described in the attached documents.

2. Scope of Supply

The bidder shall provide a covered 10–15-ton truck to transport dignity kits from Maiduguri to Benue, and an 18–30-seater bus for commodity movement within Benue. Services must include fuel, driver, insurance, and roadworthiness, ensuring timely, safe, and reliable transport to support RHHF's humanitarian operations.

Bids will be evaluated based on the following:

- Compliance with item specifications and sample quality
 - Delivery timelines and logistical capacity
 - Unit cost and value for money
 - Previous experience with large-scale supply
 - References and organizational reputation

 - **Payment terms**: 30 days after satisfactory delivery and documentation
 - **Liquidated damages** of 0.5% per day, up to 10%, will apply for late delivery.
 - **Delivery terms**: DDP Incoterms 2020
 - **Validity**: Quotes must state their validity period.
